Junior Livestock Division General Rules

- 1. The Refugio County Fair Species Committee reserves the final and absolute right to interpret these rules and regulations. The Refugio County Fair Species Committee also has the right to amend or add to these rules as its judgement may determine, with the final approval of the Refugio County Fair Board. All Agricultural Science Instructors, County Extension Agents-AG, and members of the Board of Directors of the Refugio County Fair Association and Species Committees will have the authority to spot-check feeders at any time.
- 2. Deadline for memberships <u>Friday, February 27, 2026.</u> Late entries will be accepted until 5PM on Monday, March 2, 2026; however, a \$100 late fee per entry plus entry fees will be assessed. No late entries and/or revisions will be accepted after 5PM on Monday, March 2, 2026. [For exception, see Rule No. 10.]
- 3. Boys and girls must reside in Refugio County or be enrolled in a Refugio County school to be eligible to participate in the Refugio County Fair/Junior Livestock Show. Exhibitors must be 8 years old and in 3rd-12th grade and must be actively enrolled in 4-H Online as a member of a 4-H club, Jr. FFA or FFA Chapter in Refugio County. Youth younger than 4-H age will be considered Pee Wee exhibitors and will include those youth 5 years old and in kindergarten through 2nd grade. Each exhibitor must be a member of a 4-H club or FFA program prior to validation of animals. 4-H members must be enrolled by October 31, 2025. Transfer 4-H or FFA members will be eligible for the Refugio County Jr. Livestock Show if they enrolled in the previous county by October 31, 2025.
- 4. A livestock exhibitor in the Refugio County Fair must buy or sell one membership to the Refugio County Fair Association for each project he or she plans to exhibit. Memberships must be designated at the time of purchase and typically should be assigned to the exhibitors' parents or guardians first. Any remaining memberships can be assigned to any other Refugio County adult resident as designated by the exhibitor. Membership will be good from March 2026 through February 2027. This membership will cover the 2026 year and will renew each year prior to the County Fair. Each membership is \$25.00. The maximum memberships for exhibitors with market animals will be three (3) or \$75.00. There is no limit to breeding animal memberships. Memberships and forms will be available online February 2, 2026. A link will be provided so that entries can be submitted online from the ShoWorks website. Payments will be made online at the time of exhibitor registration. Any entry submitted after Friday, February 27, 2026, will incur a \$100.00 late fee. Entries will not be accepted after 5PM on Monday, March 2, 2026.
- 5. All exhibitors must attend 50% of their 4H or FFA meetings from September to March to be eligible to show. FFA Leaders and 4-H Club Managers will complete a monthly attendance report and submit it to the Extension Office. The Extension Office will submit them to the Fair Board. The Fair Board will notify exhibitors that are not fulfilling the attendance requirement no later than January.
- 6. Each exhibitor is required to work two workdays, minimum of 2 hours each, as well as any mandatory workdays.

 Date for Mission River Classic has been changed to December 13-14, 2025
 - A. Mission River Classic tentatively scheduled for November 15-16, 2025
 - B. Annual Fundraiser Raffle tickets can be sold in lieu of work requirements
 - C. Mandatory Workday Saturday, March 21, 2026 from 8AM-12PM

Exhibitors who do not meet these mandatory requirements will be ineligible to show.

7. Youth livestock exhibitors must complete the Quality Counts program and obtain a verification number to be eligible to participate in the Refugio County Jr. Livestock Show. Quality Counts helps youth livestock exhibitors learn the importance of using proper livestock management practices. Exhibitors need to be

verified once as a Junior (grades 3-5), once as an Intermediate (grades 6-8), and once as a Senior (grades 9-12). **Pee Wee exhibitors are not required to take the Quality Counts test**. To view the program and become verified exhibitors visit the website: 0568

8. MEMBERSHIP FEES:

- 9. Each exhibitor will be allowed to enter a maximum of two (2) animals from each species but will only be allowed to show three (3) market animals from two (2) different species. For example: Entered 2 Steers, 2 Lambs, 2 Turkeys, but the day of weigh in arrive with 1 Steer and 2 Turkeys.
- 10. Entry substitutions will be allowed until Friday, March 6, 2026, and will be charged an extra \$75 per head in addition to the original entry fee. Substitutions will only be allowed if an exhibitor has sold an entered animal at a Major Livestock Show (for example: HLSR).
- 11. EXTRACURRICULAR ENFORCEMENT: ANY EXHIBITOR DETERMINED INELIGIBLE FOR EXTRACURRICULAR ACTIVITIES ACCORDING TO THE SCHOOLS' ENFORCEMENT OF SENATE BILL 1 IS INELIGIBLE TO SHOW. THE CHILD AND ANIMAL ARE BOTH INELIGIBLE. THIS *INCLUDES* PEE WEE EXHIBITORS.
- 12. Entry must be the bonafide property and under the daily feeding and care of the exhibitor. The entry must be owned and fed to the satisfaction of the supervisor (CEA or AST). In the event of an absence of the supervisor, the entry should meet the requirements to the satisfaction of the Species Committee.
- 13. Each exhibitor must furnish his own hay and feed.
- 14. No heaters or lamps will be allowed in the Show Barns for safety purposes.
- 15. Each exhibitor will be expected to always keep their space in good order. Stalls must be cleaned before 8AM each day and refuse matter disposed of at the Species Superintendents' direction.
- 16. All livestock must be kept in designated pens as assigned by the superintendents. NO EXCEPTIONS WILL BE MADE!
- 17. Sifting judges will check exhibits from 5-7PM on Wednesday, March 25, 2026, to determine quality, finish, and type of each entry. Market animals (steers, swine, lambs, goats) will be sifted and classified as needed by the species superintendents to place them in their proper classes. Entries sifted will not be allowed in the show and shall be removed from the show grounds after sifting on Wednesday night. Poultry and rabbits will be sifted at the time of check-in.
- 18. All exhibitors, excluding Pee Wee, must lead or carry animals to scales at weigh-in (adults may help at scale or weigh-in at the discretion of the supervising superintendent).
- 19. Animals will be weighed only one (1) time before 7PM Wednesday night. This will be the official weight for all purposes. NO Thursday or Friday morning weighing will be done.
- 20. Each exhibitor will be given one opportunity to confirm the animal(s) weight, should a discrepancy be suspected. Confirmation will be immediately following the initial weighing of the animal(s).
- 21. All entries must be in their assigned places in the show building or in line to unload their animals by 7PM Wednesday, March 25, 2026. If you have not unloaded by 7PM, then you must notify the species superintendent that you are in line to do so. Failure to do so will result in disqualification.

- 22. After check-in, all animals must be cared for daily (i.e., feed and water) until final disposition on Sunday morning. Division superintendents will oversee compliance. Failure to comply will result in forfeiture of resale premiums or auction proceeds. All proceeds forfeited will be dispersed at the discretion of the Livestock and Auction Committees.
- 23. Each entry in the Junior division must be shown by its owner, unless otherwise approved by the superintendent. All substitute exhibitors must be a member of a Refugio County 4-H club, Jr. FFA or FFA chapter, and meet all eligibility requirements. Only exhibitors and show officials may be in the show ring during judging. No individuals will be allowed in the holding area during the show without permission from the show superintendent.
- 24. Posted class breaks will be final with the exception of an omitted name.
- 25. Animals in all classes will be under the personal supervision of the exhibitor. In NO case will Fair management personnel or any official of the show be responsible for any loss, damage or injury to any person or property shall be assessed nor suit instituted.
- 26. Only authorized individuals and/or family will be allowed in the holding area during the show. To do so will require approval from the show superintendent.
- 27. Any wild or unruly animal will be sifted and/or disqualified and shall be removed immediately from the premises.
- 28. Any exhibitor or parent showing unsportsmanlike conduct will be barred from the show for a term determined by the Livestock Committee.

- 30. Showmanship will be judged following the selection of Grand and Reserve Champion of each species. Judges will be provided by the show management for all classes. The judges' decisions on all placings will be final. Showmanship awards will be provided for Poultry, Lamb, Goat, Swine, Rabbit, and Beef Cattle divisions.
- 31. Showmanship Eligibility: An exhibitor is eligible for the showmanship award in each species he or she owns an animal in. Jr. Showmanship for 3rd-5th grade exhibitors in all divisions. Intermediate Showmanship for

- 6th-8th grade exhibitors in all divisions. Sr. Showmanship for 9th-12th grade exhibitors in all divisions. Each exhibitor will be assigned a number to be worn when showing a livestock project. When showing an animal for someone else, the number will not be worn.
- 32. Who May Win Showmanship & How Often: Exhibitors are eligible to win the award in all species they exhibit and own an animal. No limit is set on the number of times an exhibitor may win the award during their years of show eligibility. Exhibitors must use an animal in which he/she weighed in at weigh-in on Wednesday, March 25, 2026.
- 33. Protest Policy protest concerning any livestock shown in the Refugio County Fair must be made within two (2) hours after the show of the animal in question and be accompanied by a \$200 cash deposit, which will be refunded ONLY if the protest is upheld. In the case of a protest, the Protest Committee must meet immediately to discuss and render a decision. The Committee is defined as the Species Superintendents, Executive Board Member or Representative, AST, and CEA; however, the Executive Board Member or Representative will break the tie. The vote will remain anonymous and only the outcome and action will be announced. The Protest committee has the full discretion to determine the severity of the case and issue an appropriate action. The ruling by the Protest committee will be final. Both sides of protest need to be present at time of protest. There will be no anonymous protest allowed. If the protest involves unethical drug use, a drug test will be requested by the committee and if the protest is upheld, the drug test will be paid for by the exhibitor. All protests will be documented, and records will be held by the Refugio County Fair Association.
- 34. If a **DISQUALIFICATION** occurs, the exhibitor, exhibitor parents, Species Superintendent and General Superintendent MUST all be present.
- 35. After each livestock show, the livestock show rules will be reviewed and re-evaluated. A public meeting will be held each year by each of the Species Committees to accept proposed rules and voted on and be accepted to present to the RCFA Fair Board for final approval.
- 36. Rules for next year's livestock show should be prepared and available for all exhibitors no later than September 1, 2026.
- 37. A list of superintendents' responsibilities and duties will be given to each superintendent so they will know what their job should be throughout the year. Superintendents will have the final say pertaining to enforcement and/or interpretation of show rules in their division.
- 38. Unethical practices will not be tolerated in any aspect of the Refugio County Fair. There is a strong commitment by the Refugio County Fair Board to maintain the integrity of our Junior Livestock Program. All exhibitors in the Refugio County Fair's Junior Livestock Show will have to abide by the Texas Livestock Show Code of Ethics. The exhibitor and parent must sign a contract ensuring that the exhibitor and parent understand the code of ethics.
- 39. This program is designed to be educational and beneficial to the youth of Refugio County. Any exhibitor and/or parent found to not be adhering to any rule pertaining to the Junior Livestock Show; punishment will be determined by the Refugio County Fair Board, Species Superintendents and AST or CEA which could include their entire family being banned for a period of one year to lifetime from exhibition.
- 40. All species classes, excluding poultry and rabbits, will be divided into weight classes at the discretion of the Species Committees.
- 41. If an animal is sick or deceased during the show, the exhibitor must notify the species superintendent, CEA, or AST immediately. The official will determine the next steps that must be taken. If an animal needs veterinarian care, the official Show Veterinarian will be contacted and any compensation for services will be between the exhibitor and the Veterinarian. The Refugio County Fair Association will not be responsible.

42. Health Papers: A licensed veterinarian will continue to be asked to inspect and give a blanket health certificate for the entire show. Should all animals qualify, a blanket certificate will be provided for the show.

THE FOLLOWING RULES 43-47 WILL BE STRICTLY ADHERED TO FOR ALL BEEF, SWINE, GOAT, LAMB, POULTRY, AND RABBIT DIVISIONS

- 43. <u>Animal Care</u>: All owners or persons in charge of property, or livestock, shall care for, guard, protect, and preserve same, as the Refugio County Jr. Livestock Show does not undertake to do so, and it shall not be held responsible for any loss, shrinkage, or damage to said property or the owners or exhibitors thereof. The Refugio County Jr. Livestock Show is not responsible for the acts of third parties.
- 44. <u>Unethically Fitted Livestock</u>: The showing of unethically fitted livestock, the showing of livestock of any ineligible age for exhibition in the class entered, or the misrepresentation of breeding or milking status is prohibited. Unethical fitting will be deemed to consist of changing the normal conformation of any part of the animal's body or using drugs, including over the counter and/or extra-label, or mechanical devices to alter the physical makeup and/or performance of the animal.

This includes but is not limited to the following:

- (a) Animals that are in milk due to an unnaturally induced lactation.
- (b) Balancing the udder by any means other than leaving naturally produced milk in any or all quarters.
- (c) Treating or massaging any part of the animal's body, internally or externally, with an irritant or other substance to temporarily improve conformation.
- (d) Minimizing the effects of cramping by feeding or infecting drugs and depressants or applying packs or using any artificial contrivance or therapeutic treatment except normal exercise.
- (e) Blocking the nerves to prevent limping or switching of the tail.
- (f) Striking the animal to cause swelling in a depressed area.
- (g) Surgery or other practices performed to change the natural contour or appearance of the animal's body, hide, or hair, or feet (this is to include any materials added to the feet of an animal) except the removal of warts or horns and the permitted clipping and dressing of hair and trimming of hooves.
- (h) Insertion of foreign material under the skin.
- (i) Changing the color of hair at any point, spot, or area on the animal's body. Any grooming material that allows color to come off of any animal will not be allowed at the show.
- (j) The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other method per OS (by esophagus) is prohibited.
- (k) The use of alcoholic or carbonated beverages in the feed or administered as a drench.
- (I) The use of diuretics.
- (m) Administration of a drug internally or externally. Animals under the care of a licensed veterinarian and/or taking any type of medication are ineligible.
- 45. <u>Medication</u>: All medication administered during the livestock show must be administered by the show veterinarian and a written medication record must be filed. Animals receiving performance-enhancing drugs (i.e., including, but not limited to, steroids, diuretics, anti-inflammatory, tranquilizers, and pain killers) this manner are ineligible for competition.
- 46. The term "drug" shall mean any substance for which the sale, possession or use is controlled by license under federal, state, or local laws or regulations and any substance commonly used by the medical or veterinary professions that affects the circulatory, respiratory, muscular, skeletal, or central nervous system

- of any species of livestock. If drugs are used by an official show veterinarian to treat a recognized disease in the market animals, the withdrawal times listed by the drug manufacturer will be strictly followed.
- 47. <u>Veterinarians/Medications</u>: Animals under the care of a licensed veterinarian and/or taking any type of performance-enhancing medication to include, but not limited to, steroids, diuretics, anti-inflammatory, tranquilizers, and pain killers, are ineligible for competition. Exhibitors with questions regarding medications and/or eligibility should consult with the official show veterinarian prior to competition.

THE TEXAS LIVESTOCK SHOW CODE OF ETHICS

This code of ethics applies to anyone exhibiting animals at livestock shows in Texas. It includes Junior as well as open class exhibitors who compete in structured classes of competition. All classes of livestock offered at the livestock event are included. Cattle (Beef and Dairy), Goats (Angora, Boer, Dairy, Meat, Cashmere), Equine (Donkey, Horses, Mules), Llamas and other specialty animals, Poultry, Rabbits, Sheep, Swine, and any other livestock classes offered. This "Texas Stock Show Code of Ethics" will be enhanced with additional rules and regulations which individual fairs and livestock shows impose on the local, county, state, regional and national levels.

The following practices or procedures are unacceptable and are defined as being deceptive, fraudulent, unethical, and inhumane in the care, fitting, preparation and showing of all classes of livestock. The use of any illegal drugs is prohibited. Legal or illegal substances used to phenotypically alter the appearance of an animal entered in livestock events are prohibited. (See rule #4.) Use of illegal drugs is considered a pre-meditated act! Furthermore, any information obtained in the practice of illegal alteration of an animal will be turned over to the proper authorities for possible criminal prosecution. **THIS IS A ONE STRIKE AND YOU ARE OUT POLICY!** Exhibitors will forfeit any premium, awards, or auction proceeds and will be prohibited from further competition at future shows in Texas, as well as being subject to potential criminal prosecution.

The following is a listing of guidelines all exhibitors must follow to enter livestock at organized competitive events:

- 1. All exhibitors must have viable proof (Junior Division) of ownership available to prove the length of time animals have been owned. Market animals (Beef, Sheep, Swine, Goats) must be owned and under exhibitor's daily care by the following dates: June 30 Steers, October 31 Sheep and Goats, November 30 Hogs, to be eligible to participate at all major stock shows within Texas. This also includes small market animals (rabbits and poultry). The official ownership date is the date shown on the bill of sale or receipt of sale, unless the animal was bred by the exhibitor, in which calving, or birth records will be utilized. (Individual show rules may determine ownership requirements for non-market animals.) Registered breeding livestock must show the exhibitor as the sole owner of the animal on the breed association papers or certificates.
- 2. No exhibitor may show a market animal which has been previously sold at an auction or sale as a market animal through another local, regional or major livestock show. Any method used to misrepresent the age of an animal for a class in which it is shown is deceptive and considered illegal. Showing an animal for another individual by claiming ownership in order to show in a specific livestock class or event is prohibited. False ownership is illegal.
- 3. Treating an animal internally or externally, with any irritant, counter-irritant, or other substance used to artificially change the conformation or appearance of an animal for show is considered unethical, inhumane, and is prohibited. This includes, but is not limited to the use of graphite, air, powders, hemp, artificial hair coloring, common products such as fly spray, ointment or liniment used to the point that it is irritating, (unless required to reduce edema at time of calving) or similar type products. Adding false hair or hair-like material, fleece, or skin at any point, spot, or area of the animal's body is illegal and will result in immediate disqualification. Utilization of any liquid or substance not considered part of an accepted and normal diet for livestock is deemed illegal and inhumane.
- 4. The use of tranquilizers, sedatives or depressants which alter the physical or physiological state of the animal is illegal. Exceptions to this rule would be a licensed show veterinarian's treatment for a recognized

disease or injury. All drugs must be approved by The Food and Drug Administration for use in meat producing animals. All exhibitors shall advise show management of any drugs and/or medications administered to an animal that might be detected at the time of showing or at meat inspection. The name of the drug, its purpose, the person who administered the drug, time and date of administration shall be presented to show management prior to showing and sale of the animal. Failure to report this information to the show management will result in severe penalties and/or disqualification. Any use of drugs or substances not approved by The Food and Drug Administration is strictly prohibited. All animals entered into livestock competition shall be subject to testing for foreign substances that exceed acceptable levels established by the FDA, FSIS, USDA, or EPA. During livestock events, in the case of an animal requiring treatment, all medications shall be administered by a licensed show veterinarian and the livestock show officials shall be notified.

- 5. Surgery, injection, or insertion of foreign material under the skin and/or into the flesh of an animal to change the nature contour, conformation or appearance of an animal's body is illegal. This includes vegetable oil, air, silicon, or any other substance used to alter the shape of the animal. Acceptable practices of physical preparation which are allowed include clipping of hair, trimming of hooves, dehorning, removal of ancillary teats and docking of tails.
- 6. The balancing of the udder by abnormal means that includes the use of a mechanical contrivance or the injection of fluids or drugs, setting the teats and/or occluding (sealing the ends) with a mechanical contrivance or with the use of a chemical preparation is illegal. Treating or massaging the udder or its attachments with an irritant or counterirritant is prohibited.
- 7. The use of inhumane fittings, showing and/or handling practices or devices shall not be tolerated. For example, breaking of tails, striking of the animal to cause swelling or for bracing purposes, use of electrical contrivance or use of overly severe bits is not acceptable and prohibited.
- 8. Direct criticisms or interference with the judge, show management, other exhibitors, breed representatives or show officials before, during or after the competitive event is prohibited.
- 9. At the time an animal is sold at auction at the livestock show, the exhibitor shall be held directly responsible for animals that are rejected at a processing center due to the presence of foreign residues. The seller may be liable to the buyer for an amount equal to three (3) times the purchase price and may also be liable for attorney's fees and civil penalties. Show management may share acceptable intelligence and evidence information with FDA and USDA. If for any reason, any part of a meat animal carcass must be removed by the FDA or USDA inspectors, the market price will be discounted.
- 10. Show management reserves the right to require animal health certificates. Health inspectors and diagnostic tests may be made before or after animals are on the livestock show premises for exhibitor and animal safety, or to inaugurate disease control procedures which may become necessary in emergencies as determined by animal health officials.

Any violation of "The Texas Livestock Show Code of Ethics" or specific rules as designated by individual fairs and livestock shows may result in forfeiture of premiums and awards, disqualification, and may result in probationary status and/or loss of eligibility for future participation in organized livestock competition. Possible civil penalties may be imposed by the proper authorities based on evidence provided by the livestock show of exhibitors in violation of the Federal Food, Drug and Cosmetic Act/or the animal mistreatment, neglect, and abandonment laws that apply on the local, state, and national levels. All rule violations will be dealt with on an individual basis by a committee composed of show management, 4-H, or FFA members, parents, and show superintendents. This can include part or all of these individuals and will be conducted on an as needed basis deemed necessary by show management. Other shows will be notified of the action taken by show management, which may affect the eligibility of the individual, group, or sponsoring organization for participation at other shows. The decision of the oversight committee will be final.

Commercial Heifer Division Rules

Ryan Deal, Superintendent Commercial Heifer Judging – Wednesday, March 25, 2026

- 1. Participants may exhibit two pens of two heifers in his or her name.
- 2. A pen will consist of two open heifers approximately 14-16 months of age.
- 3. Any breed or cross breed is acceptable.
- 4. Heifers must be dehorned or tipped to quarter dollar blunt tips.
- 5. Heifers must have brucellosis tag from veterinarian prior to validation.
- 6. Participants may validate up to three heifers per pen, two heifers for the pen and one alternate.
- 7. For heifers to be eligible to show, they must be validated by the cattle superintendent or designated committee member on or before December 2, 2023.
- 8. All heifers will be pictured and tagged with a special ear tag furnished by the Livestock committee. If the ear tag is lost during the feeding period, it must be reported to the cattle superintendent or County Agent for replacement.
- 9. Health papers for heifers must come from veterinarian and show heifers open no earlier than 30 days prior to show. Health papers must be turned in at check-in to protect the integrity of the show.
- 10. Division classes shall consist of:
 - a. Junior (3rd-7th Grade)
 - b. Senior (8th-12th Grade)
- 11. Grand Champion and Reserve Champion will be selected from the champion and reserve division champions.
- 12. Heifers and participants will be judged by the same panel of three judges acquired by the cattle committee and County Agent.
- 13. Judging shall consist of:
 - a. Heifer quality 60%
 - b. Two-minute oral sales pitch 20%
 - c. Oral quiz (maximum 15 questions) 20%
- 14. Potential questions for oral quiz will be shared with participants at least 60 days prior to show at an organized meeting. Examples of sales pitch will also be shared.
- 15. For 2027 a second class will be added: BRED HEIFER Class those rules will be added.

- 8. **Minimum weight at check-in will be 1000 lbs and a maximum weight of 1600 lbs. NO weight tolerance will be allowed.** Exception All Miniature Breeds minimum weight at check-in will be 850 lbs. All miniature breeds must be accompanied by registration paperwork. All steers must be castrated, dehorned, and completely healed at check-in or the animal will be sifted.
- 9. If an animal has been through official check-in (weigh-in and/or sifting) it cannot be replaced by another animal in that division or any other division. No substitutions after weigh-in and sifting.
- 10. No paint will be allowed.
- 11. Cordless clippers may be used to trim at show. No full clipping may be done, only touch up.

- 1. The purpose of this show is to give Pee Wee youth an opportunity to participate in the Refugio County Fair. Participants will learn responsibility and sportsmanship.
- 2. The Pee Wee Cattle Show is open to youth 5 years of age and enrolled in kindergarten through 2nd grade of the current school year, must reside in Refugio County or live in a Refugio County School District and must be actively enrolled in 4-H Online as a member of a 4-H club to be eligible to show.
- 3. Showmanship of the exhibitor is the only quality that will be judged.
- 4. Heifers and steers may be any mini breed.
- 5. Maximum height to be shown in these classes is 45" on mature females and 48" on mature steers. All entries will be measured prior to showing. Those exceeding the height requirement will be disqualified from competition.
- 6. Exhibitors will be required to enter the show ring with assistance from a parent/guardian who is at least 18 years of age or a senior qualified exhibitor. This is strictly for the safety of the youth. If an animal is at any time deemed unruly, it may be banned from showing by any show official.
- 7. Cattle will be required to be on feed by Nov 1st and will be verified by CEA or AST. No exceptions will be made.
- 8. No clipping will be allowed on the grounds.
- 9. This will be a blow and go show. There will be no adhesives or paint allowed.
- 10. All participants will receive a trophy and ribbon. Showmanship will be a special award, which will be selected by the judge and presented to only one exhibitor.
- 11. Pee Wee Cattle will not be eligible for the premium auction.

A participant must be 5 years of age and enrolled in kindergarten through 2nd grade of the current school year, live within Refugio County or attend a school in Refugio County and must be actively enrolled in 4-H Online as a member of a 4-H club to be eligible to show.
- 2. Each exhibitor must be in kindergarten 2nd grade to be eligible.
- 3. Goat may be a wether or an unbred doe. The goat must be in the exhibitor's possession and on feed by January 2, 2026.
- 4. Pee Wee goat exhibitors will be allowed to borrow a goat from a Junior Exhibitor. Exhibitor's parents must notify the County Extension Agent in writing between December validation and January 2, 2026, to be eligible to show. No exceptions will be made. At the time of notification, a mentor exhibitor (one of 4-H or FFA age) must be listed for the Pee Wee exhibitor.
- 5. Pee Wee goats' horns MUST be tipped prior to show.
- 6. Minimum weight of 40 lbs. Maximum weight of 125 lbs. No exceptions.
- 7. There is no tooth rule.
- 8. Neck collars and halters with leashes are optional for showing goats.
- 9. Goats should be shorn no more than 1 week before show. Hair should be no longer than 1/4 inch at show.
- 10. A champion showman will be selected, and an award given.

Market Poultry Division Rules

Irene Porras, Superintendent Market Poultry Show – Wednesday, March 25, 2026 @ 7:30PM

THE CLASSIFIER'S VISUAL DECISION IS FINAL!

- 1. All poultry will be ordered and purchased through the direction of the County Extension Agent. All poultry will be ordered from one hatchery, will be of the same breeding and will be hatched the same day. All birds will be ordered straight runs.
- 2. Each exhibitor must order the minimum number as stated in the chart below:

Broiler	1 exhibitor 25	25	
	2 or more exhibitors	50	
Turkeys	25	25	

If an exhibitor wishes to order more than the minimum, they must be ordered in lots as designated above.

- 3. All poultry will be wing-banned at the hatchery. Only wing-band numbers originally assigned to individual exhibitors and/or a family will be accepted. If a bird loses a band or they are tampered with, the individual bird is automatically disqualified from the show.
- 4. Poultry will be sifted at the time of check-in. During the check-in process each exhibitor will be responsible for presenting their entry to the sifting judge. The sifting judge will be looking for broken limbs, bruises, blisters, parasites, cleanliness, and overall quality. Adults may help at check-in at the discretion of the supervising superintendent.
- 5. Exhibitors will not be allowed to return home or leave the fairgrounds to replace a bird that has been sifted. Due to the fragile nature of poultry during transit, problems do and will occur. It is advised that exhibitors bring extra birds, if possible, to the check-in. (Need to bring 4 birds per pen, and all of them to the sifter and one time to be replaced in front of the superintendent and sifter.). Exhibitors will not be allowed to return to the vehicle, house, etc. for extra birds.
- 6. Exhibitors will not be allowed to store feed and shavings or any other items under the poultry pens.

 Appropriate boxes may be used to store these items if desired. The obvious purpose of this is to have a more attractive show barn.
- 7. If an exhibitor has more than one bird per class, substitute exhibitors who are any school aged child that resides in Refugio County will be permitted to assist in the ring. It is the exhibitor's responsibility to find help before judging.
- 8. Ribbons will be awarded through 10 places. Grand and Reserve Champion prizes will be awarded.

 BROILERS: An entry consists of three broilers of either sex. Limit two entries per exhibitor. Broilers will be approximately 7 weeks of age. The show management reserves the right to divide the broilers into heats at their discretion depending on the number of entries. Exhibitors must have birds sorted into a pen of three prior to check-in.

TURKEYS: An entry shall consist of a single turkey hen or tom. Limit two entries per exhibitor.

- 1. An entry will consist of a pen of three rabbits of the same breed and variety. Each rabbit must weigh a minimum of 3 lbs. 8 oz. and a maximum of 5 lbs. at weigh-in. A 2-ounce weight tolerance will be allowed.
- 2. Each exhibitor may show a total of 2 pens of (3) fryers. Validation will be in February. Each exhibitor will be allowed to validate no more than 10 rabbits. Each additional rabbit over 10 will be charged \$5 per rabbit.
- 3. Rabbits showing signs of obvious disease (ear canker and/or ear mites, sore hocks, bad eye, buck teeth), or other illnesses will be sifted from the show. These animals must be removed from the grounds immediately.
- 4. Only two pens of rabbits may be brought to the official scales, with no more than one substitute allowed for each pen. If a sifted rabbit cannot be replaced by a qualified substitute, the entire pen will be sifted.
- 5. All rabbits will be shown in one division.
- 6. Rabbits must be Californian or New Zealand breeds. No crosses.
- 7. All exhibitors must have rabbits sorted into a pen of three prior to check-in.
- 8. The show management reserves the right to divide the rabbits into heats at their discretion depending on the number of entries.
- 9. Ribbons will be awarded through 10 places. Grand and Reserve Champion prizes will be awarded.

YOUTH LIVESTOCK AUCTION ASSOCIATION

Market Livestock Auction Rules

1. This will be a controlled auction. In other words, the highest selling animal in a division sets the maximum bid allowed. An animal can sell up to the highest price of the reserve champion of each species, including the bumps in the auction. Auction lots that have met their maximum will be allowed a \$3000 add-on. Outback lots will be limited to \$1000 in total add-ons. Recognized support groups shall have the ability to disburse funds over and above the maximum add-on amount. The Auction Association Board of Directors will have final approval of the distribution of funds. A Recognized Support Group must be pre-approved by the Auction Association Board of Directors prior to the auction.

Exhibitors can only sell two (2) lots unless they have three (3) Grand or Reserve Champions, in which case all three (3) must sell in the auction. If an exhibitor has three (3) exhibits that qualify for the auction below Grand or Reserve Champion, they must decide as to which two (2) exhibits they will sell. A 6% or less commission will be taken from each auction lot sale to be used as working capital.

- An auction sale will be held for those animals earning such privilege. A resale price will be obtained prior to the sale. The Youth Livestock Auction Association or a committee designated by the Association will set the floor price for the auction. The floor price will be no more than the resale bid acquired for each species.
- 3. Disposition of animals (EXCLUDING POULTRY AND RABBITS) sold in the auction will be made by the buyers on the auction bid form.
- 4. Animals will be sold only once during the auction.
- 5. Animals will be sold in the following order: Steers, Lambs, Hogs, Goats, Turkeys, Broilers and Rabbits.
- 6. Sale Eligibility:

<u>STEERS</u>: A minimum of 10 steers, or maximum of 75% (whichever is the greater value) in the show, including Grand and Reserve (not to exceed 36 steers) will be allowed in the auction. Placing eligibility of each breed represented in the show will be determined after check-in and prior to the market steer show. Lower placing steers in the Grand and Reserve classes will not "move up" and will not be eligible for auction.

LAMBS: A minimum of 10 lambs, or a maximum of 75% (whichever is the greater value) in the show, including Grand and Reserve, (not to exceed 16 lambs) will be allowed in the auction. Placing eligibility of each breed represented in the show will be determined after check-in and prior to the market lamb show. Lower placing lambs in the Grand and Reserve classes will not "move up" and will not be eligible for auction.

SWINE: A minimum of 10 swine, or a maximum of 75% (whichever is the greater value) in the show, including Grand and Reserve (not to exceed 48 hogs) will be allowed in the auction. Placing eligibility of each breed represented in the show will be determined after check-in and prior to the market swine show. Lower placing hogs in the Grand and Reserve classes will not "move up" and will not be eligible for auction.

GOATS: A minimum of 10 goats, or a maximum of 75% (whichever is the greater value) in the show, including Grand and Reserve, (not to exceed 16 goats) will be allowed in the auction. Placing eligibility will be determined after check-in and prior to the market goat show. Lower placing goats in the Grand and Reserve classes will not "move up" and will not be eligible for auction.

POULTRY: 12 turkeys and 12 pens of broilers will be allowed in the auction including Grand and Reserve champions. Placing eligibility of each gender represented in the turkey show will be determined after check-in and prior to the market turkey show. Lower placing turkeys and broilers will not "move up" and will not be eligible for auction.

RABBITS: 15 pens of rabbits will be allowed in the auction including Grand and Reserve champions. Lower placing rabbits will not "move up" and will not be eligible for auction.

- 7. All market animals will be under the control of the Youth Livestock Auction Association after all judging is completed. Exhibitors must inform the Auction Directors within two (2) hours after judging is completed if they do not want to sell their animals in the auction or on the outback sale. NO market animals will be allowed to be removed from the show grounds without an official signed release from the Auction Committee. Violators will be subject to criminal prosecution and all auction proceeds will be forfeited.
- 8. Exhibitors must continue to care for their animals until they are removed from the show grounds. Failure to care for animals in a humane manner (i.e., feed and water) will result in a minimum \$200.00 fine and a maximum penalty of the forfeiture of all proceeds from the sale of the animal in the auction. Violations may be determined by auction officials, livestock show officials, livestock show veterinarian and contracted processors. All suspected violations will be verified by a licensed veterinarian. Forfeited auction proceeds will become the property of the Youth Livestock Auction Association to be used for reimbursements and expenses incurred due to the violation.
- 9. In the situation where an exhibitor has three (3) lots eligible for auction, he or she must notify the superintendent of the specific animal or food item to be withdrawn. Should notification not be made, the committee completing the sale order will have authority to make the best decision for that exhibitor.
- 10. Animals not included in the auction will be offered for sale on the "out back sale list". These animals will be offered for sale by the head. The price will be determined by the Directors of the Auction Association. If the animal neither qualifies for the auction or remains unsold "out back", the exhibitor will be paid market value (floor price) with the exception of poultry and rabbits. All poultry and rabbits that remain unsold will not receive payment.
- 11. Official R. C. F. A. ear tags must remain on all animals. All other tags must be removed prior to auction.
- 12. To be eligible to participate in the Livestock & Youth Food Auction, exhibitors must be in school grades 3-12.
- 13. Pee Wee goats may, by request, be sold to the resale buyer at the stated floor price. All commission charges will be applied.
- 14. Exhibitors are required to clean their assigned stalls/pens by 6:00PM Sunday following the show and sale. A \$50 cleaning fee will be charged for each stall/pen not cleaned. (All fees collected for cleaning will be paid to R. C. F. A)

- 15. All poultry and rabbits must be taken home by exhibitors. All poultry and rabbits will be sold as a premium sale only. Buyers of premium sale lots will not receive any product. Exhibitors will not be required to deliver poultry or rabbits to the buyers. Animals being picked up by buyers must be removed by 7:00AM Sunday morning.
- 16. All animals must be in their designated stall/pen prior to load out.
- 17. A maximum of 5 food items will be allowed in the auction. Following General Rules, food items in the auction will receive a maximum of \$300. Any amount over \$300 per lot, including add-ons, will be evenly distributed to youth exhibitors participating in the Exhibit Building.
- 18. Thank you letters to buyers are required from all exhibitors to all buyers, add-on supporters, and sponsors of awards. Letters (addressed, stamped, and sealed) must be turned in to the Extension Office no later than two (2) weeks from the date the buyer list is distributed to exhibitors. Failure to turn in letters by the due date will result in a \$200 late fee deducted from exhibitor's check. Checks will not be released until the exhibitor turns in thank you letters.
- 19. The Picante Sauce winning entry will be sold at the auction. All proceeds will be used for scholarships. Funds will be administered by the Youth Livestock Auction Association. The Picante Sauce winner will receive a \$100 prize. This prize may be donated or taken from the scholarship fund if necessary.
- 20. Exhibitors and/or parents that do not follow the rules of the Youth Livestock Auction Association are subject to Rule #28 on page 8 of the Livestock General Rules.
- 21. Youth Livestock Auction Association Rules will be revised one time each year at the annual meeting to be held during the month of April. All rule change proposals must be submitted in writing to the County Extension Office not later than April 15 and must include name and contact information. Only presubmitted rule change proposals will be considered for revision at the annual meeting.
- 22. The Youth Livestock Auction Association Board of Directors reserves the final and absolute right to interpret these rules and regulations and the right to amend or add to these rules as its judgment may determine.
- 23. The Youth Livestock Auction Association will not be liable for payment of any add-on pledges that are not collected.

YOUTH FOOD AUCTION RULES

NOTE: TO ALL YOUTH FOOD DIVISION PARTICIPANTS

All food items auctioned will have a maximum of \$300 to go to the entrant. If an item sells for more than \$300 or gets add-on, the surplus will be used as a supplement paid on youth entries in the Expo Building, excluding school divisions. Each food auction participant must re-bake their winning food item for the auction on Saturday, March 22. A participant can auction a total of two (2) items, animals, and foods. The food auction will follow the Livestock Auction.

COMMERCIAL HEIFER AUCTION RULES

COMMERCIAL HEIFERS EXHIBITED IN THE REFUGIO COUNTY FAIR YOUTH COMMERCIAL HEIFER SHOW WILL BE SOLD BY AUCTION IMMEDIATELY FOLLOWING THE MARKET LIVESTOCK AUCTION. ALL PENS OF HEIFERS EXHIBITED WILL BE ALLOWED IN THE AUCTION, SEPARATE AND ASIDE FROM THE RULES GOVERNING THE MARKET LIVESTOCK AUCTION. A SALE ORDER WILL BE PRODUCED BY THE COMMERCIAL HEIFER COMMITTEE. PAYMENT FOR THE SALE OF ALL HEIFERS WILL BE MADE PAYABLE TO "THE YOUTH LIVESTOCK AUCTION ASSOCIATION" AND WILL BE COLLECTED BY THE COMMERCIAL HEIFER COMMITTEE PRIOR TO BUYERS PICKING UP AND TAKING POSSESSION OF ANY HEIFERS. A 6% OR LESS COMMISSSION WILL BE TAKEN FROM EACH AUCTION LOT SALE. CHECKS TO EXHIBITORS FOR THE COMMERCIAL HEIFER SALE WILL BE ISSUED AS SOON AS ALL ACCOUNTS ARE SETTLED AND CHECKS ARE CLEARED THROUGH THE BANKING INSTITUTION OF RECORD. THE COMMERCIAL HEIFER COMMITTEE WILL BE RESPONSIBLE FOR PRODUCING AND DISPLAYING PHOTOS OR VIDEO OF THE HEIFERS AS THEY ARE AUCTIONED AND WILL BE RESPONSIBLE FOR LOAD OUT OF ALL HEIFERS FOLLOWING THE SALE.

PICANTE SAUCE CONTEST RULES

Bring your entry to Padilla Hall shortly before noon on Saturday, March 22. Contestants need to bring two (2) separate pint containers of their recipe (one used in judging and one for possible auction). Contestants can mix a fresh batch or use entries they have canned. Any ingredients which make a picante or "hot sauce" are eligible. There is no entry fee for this contest. The winning entry will go to auction. The auction money will go toward scholarships which will be awarded to local high school seniors who are participating in the Junior Livestock Show and/or in the Expo Building. The winner will receive a \$100 prize.

EXPO BUILDING

THE PURPOSE AND MISSION OF THE EXHIBIT BUILDING IS TO PROMOTE PARTICIPATION AND INVOLVEMENT FROM THROUGHOUT THE COUNTY.



GENERAL RULES

- <u>PRE-ENTRIES</u>: All exhibits must be pre-entered. Pre-entry cards (not the items entered) will be accepted at the County Extension Office, 414B N. Alamo St, Refugio, TX 78377. <u>Pre-entry cards can be turned in between January 2, 2026, and March 9, 2026</u>. Any entry submitted after the deadline will be subject to a \$10 late fee, and all proceeds from late entries will be used for trophies, ribbon, etc.
- 2. Each exhibitor will be charged an entry fee PER EXHIBITOR as follows:
 - a. \$2 per youth and \$5 per adult.
 - b. The flat fee will be charged regardless of the number of entries submitted.
- 3. Refer To Each Division for Number of Entries Allowed
- 4. Any article previously exhibited in the Refugio County Fair may not be exhibited again, except for Horticulture.
- 5. All entries must be made by the person in whose name they are entered except for Quilts.
- 6. All entries must be clean and unsoiled at the time of check-in. Entries not meeting these criteria will be immediately removed from the Exhibit Building if possible. If entry remains, it will not be judged or exhibited.
- 7. Competitive entries will be limited to residents and taxpayers of Refugio County, students (and their parents) enrolled in Refugio County schools, or those who work full-time in Refugio County. Any other entries will be for display only.
- 8. <u>CHECK-IN</u>: All tags must be attached to the item before check-in. All items must be checked in with one of the superintendents who will issue a claim stub. This stub must be presented before any item is released at the close of the Fair. If the item is not checked in during the designated times, it will not be accepted.
- 9. **JUDGING**: Trophies, rosettes and ribbons will be presented to blue, red, and white ribbons according to the merit system. The merit system is a grading system based on 90-100 is a blue ribbon, 80-89 is a red ribbon, and 70-79 is a white ribbon. One rosette will be awarded per class. Judges might not award a rosette in a small class if they choose. One youth and one adult trophy will be awarded in each division.
- 10. Where there are only one or two entries in any class, the judge will award places and ribbons according to the merit system.
- 11. The Refugio County Expo Building Committee reserves the final and absolute right to interpret these rules and regulations and the right to amend or add to these rules as its judgment may determine.
- 12. THE DECISION OF THE JUDGES WILL BE FINAL.
- 13. An award will be presented to the high point overall exhibitor in the Adult and Youth Division. (Note: High point score will be based on total highest score in each division excluding school art.) The following point system will be used to determine the high point winner:

- 14. **DISPLAYS**: The Refugio County Fair Association will take all reasonable precautions for items exhibited in the Expo Building; however, the Fair Association will not assume responsibility for any items lost, stolen or damaged.
- 15. **AUCTION**: Youth must be 9 years old or 8 years old and in the 3rd grade, and not over 18 years old as of August 31st of the current school year. It is the responsibility of the youth to verify if their food item has made the auction. Youth who qualify for the food auction must notify the building superintendent of

- intent to auction within two hours after completion of animal project judging. Food items must follow auction rules. **See page 32**.
- 16. All entries are to be picked up on Saturday, March 28th between 4:00-5:00PM. **YOU MUST HAVE YOUR ENTRY STUB TO PICKUP JUDGED ITEMS**. All baked good items not sold will be discarded at the end of the checkout time (5:00PM) if not picked up by participant.
- 17. All youth baked goods will be sold starting Thursday, March 26th at 6:00PM for \$10.00 per item. Each youth that sold an item will receive the money at check-out time.
- 18. "NO" one will be allowed in the Expo Building on the day of judging except for the superintendents, judges, and staff in charge of the Expo Building. Once items have been checked in to be judged, participants are asked to leave the building. The Expo Building will re-open to the public on Thursday, March 26th at 11:00AM.

BAKED GOODS DIVISION

RULES: All items may be accepted but could be disqualified at judging if entry does not comply with all the rules.

- 1. See General Rules page 34
- 2. One entry per lot.
- 3. All items will be judged for taste, texture, and appearance.
- 4. Each entry in the show must be made by the person under whose name it is entered.
- 5. All baked goods, except for decorated cakes, must be exhibited in a sealed, closed, disposable container with a clear plastic dome lid that may be purchased at the Extension Office. All items must have a black plastic bottom and clear, sealable dome lid. If not in the correct container, the item will be disqualified.
- 6. No refrigerated items such as cheesecakes, whipped cream, cream pies, gelatin, etc. will be judged. The purpose for this rule is to avoid possible food spoilage.
- 7. Recipes will be required with all baked food items. The recipe should be typed on an 8.5 x 11 sheet of paper and taped to the top of each container. Recipes are not required for decorated cakes. Entries without recipes or which are not attached to the top will have a 10-point deduction from the score.
- 8. The entry tag must be attached to the food container prior to check-in.
- 9. Cakes, pies, and bread entries should contain the whole entry in one piece. The minimum size of cookies, candy, cupcakes, etc., entries should be AT LEAST 24 pieces.
- 10. The Top 5 youth items from the baked goods division, except for decorated cakes, will qualify for the auction.
- 11. Food items submitted will become the sole property of the Expo Building Committee. Should the committee decide to do so, they may sell samples of the baked goods to attendees.
- 12. Any food items and/or containers not picked up during the designated time will be disposed of by the Expo Building Committee. Containers not complying with the present rules but allowed will also be disposed of.

ART DIVISION

Adult and Youth Framed Art Rules

RULES: All items will be accepted, but may be disqualified at judging, if the entry does not follow the rules.

- 1. See General Rules page 34
- 2. Artists may enter no more than four (4) entries per class.
- 3. Pictures must be dry prior to submission. Except for Class 6 & 7, art entries must be framed. A mat may be used to enhance artwork, but a frame must also be used.
- 4. All entries must have a **separate** wire hanger **securely** attached and be ready for hanging. Otherwise, the exhibit will be disqualified. NO TAPED-ON HANGERS!
- 5. All entries must be original. No copies, number paintings, nude paintings or paint along will be accepted.
- 6. Signatures on artwork must be covered for judging. It is the responsibility of the entrant to cover the name before check-in.

CLASS 1: Oil or Acrylic (Oil Techniques)

CLASS 2: Watercolor or Acrylic (Watercolor Techniques)

CLASS 3: Graphics (charcoal, pencil, pen & ink)

PHOTOGRAPHY DIVISION

RULES: All items will be accepted, but may be disqualified at judging, if the entry does not follow the rules.

- 1. See General Rules page 34
- 2. Each Exhibitor may exhibit no more than one (1) entry in each lot per class.
- 3. Each photo should be pre-entered with the information to include exhibitor's name, address, and age.
- 4. Each entry must have a completed entry tag attached to the FRONT of the photo.
- 5. All entries must be framed with a stand attached SECURELY to the back of the frame. NO DECORATIVE FRAMES WILL BE ALLOWED, PLAIN BLACK FRAME PREFERRED. All entries not in compliance will be disgualified and will not be displayed.
- 6. LOT A-F should be single photos only.
- 7. CLASS 1 & CLASS 2 are for <u>Amateur</u> Photographers.
- 8. CLASS 3 & CLASS 4 are for <u>Professional</u> Photographers.
- 9. ALL photos can be either film or digital, regardless if the photo is color, black & white, sepia. NO exceptions.
- 10. The measurement of framed photos can be no larger than 8½ x 10½ or smaller than 5 X 7 including matting. Photos submitted that are larger than the specified size will be disqualified and will not be judged or exhibited.

SCHOOL ART DIVISION



SCHOOL ART DIVISION

RULES: All items will be accepted, but may be disqualified at judging, if the entry does not follow the rules.

- 1. Work done at school will be entered by the teacher and will be limited to one (1) entry per student.
- 2. School art must be <u>matted</u> but unframed. Entries through the 8th grade should measure no larger than 9" x 12", including the mat. High school entries ONLY may be no larger than 10" x 14", including mat and must have a hanger attached.
- 3. School art will be displayed according to grade level nursery through 12th grade.
- 4. No premiums or supplements will be paid.
- 5. Ribbons will be awarded by the merit system with one rosette per grade level.

SCHOOL SCULPTURE DIVISION

RULES: All items will be accepted, but may be disqualified at judging, if the entry does not follow the rules.

- 1. Work done at school will be entered by the teacher and will be limited to one (1) entry per student.
- 2. School sculptures will be displayed and judged according to grade level nursery through 12th grades.
- 3. No premiums or supplements will be paid.
- 4. Ribbons will be awarded by the merit system with one rosette per grade level.

INDUSTRIAL / AG MECHANICS DIVISION



AG MECH DIVISION

Metal and Woodworking Projects

ELIGIBILITY:

- 1. General Rules must be followed to participate in the Ag Mech Division.
- 2. Projects must have been constructed by the exhibitor within the twelve months preceding the show.
- 3. Cost of Entries will be \$10.00 per entry. Projects may be entered by an individual or group. You can enter as many projects as you want, but only one project per category.
- 4. All projects must be constructed under the supervision of Agricultural Science Teachers, County Extension Agent, or 4-H Leaders. A group can be no more than 6 people. Groups must name the individuals in the group at the time of entry. If a group loses a member, the group is still eligible, but they cannot replace the member. You can enter as many projects as you want, but you can only enter one project per category.
- 5. Exhibitors must declare project description by March 1st.
- 6. All exhibitors must attend 50% of their 4H or FFA meetings from September to March to be eligible to show. FFA Leaders and 4-H Club Managers will complete a monthly attendance report and submit it to the Extension Office. The Extension Office will submit them to the Fair Board. The Fair Board will notify exhibitors that are not fulfilling the attendance requirement no later than January.
- 7. Each exhibitor is required to work two workdays, minimum of 2 hours each, as well as any mandatory workdays.
 - A. Mission River Classic tentatively scheduled for November 15-16, 2025
 - B. Annual Fundraiser Raffle tickets can be sold in lieu of work requirement
 - D. Mandatory Workday Saturday, March 21, 2026 from 8AM-12PM

Exhibitors who do not meet these mandatory requirements will be ineligible to show.

AWARDS:

- Team project winners will receive a trophy for the school to display and banners will be presented to each team member.
- A buckle will be given to individual project winners for Grand Champion and Reserve Champion in both the Jr. and Sr. Division.
- Ribbons will be awarded to 1st, 2nd, and 3rd place entries.
- Additional prizes will be awarded if they become available.

GENERAL RULES:

- 1. All projects must be checked in by the Ag Mech Committee on Wednesday of the show from 9AM-12PM. The Ag Mech Committee will designate the location of all projects.
- 2. Judging of Projects will be on Wednesday at 1PM.
- 3. Ag Mech Awards will be given awarded at a time to be announced.
- 4. All projects must be complete and finished by the time they move into the show area. Exhibitors must provide trailer paperwork (Proof of Registration) at check in or have certified weight ticket.
- 5. All projects must have a sign displaying club or chapter and exhibitor(s).
- 6. Entries will be divided into Junior and Senior Divisions.
- a. Junior Exhibitors are defined as 3rd 8th grade as of September 1.
- b. Senior Exhibitors are defined as 9th 12th grade as of September 1.
- 7. Entries will be categorized into appropriate classes for judging. The Superintendent has the right to place projects into classes and create new classes as needed.
- 8. Ag Mech projects can leave Saturday and must be out by 11AM.
- 9. Allow buckles for team projects if a team is a winner with sponsorship for extra buckles.

DIVISIONS:

- 1. Agricultural Machinery and Equipment Examples: Trailers, Shop Equipment, Tractor Equipment
- 2. BBQ Pits and Outdoor Cooking
- 3. Truck Accessories Examples: Bumpers, Receiver Baskets, Headache Racks
- 4. Livestock and Wildlife Equipment Examples: Deer Blinds, Feeders, Trim Chutes
- 5. Home Examples: Furniture, Dining Room Tables
- 6. Yard Examples: Swings, Picnic Tables
- 7. Reclaimed Repurposed Wooden Pallet Projects

RECORD BOOK REQUIREMENTS:

- A. Student generated plans with measurements (hand drawn or computer generated)
- B. Labeled photographs showing stages of construction
- C. Bill of materials
- D. Properly displayed in a 3-ring binder or folder (NO POSTER BOARDS)

Appropriate safety measures must be taken to ensure the safety of all those at the show. Sharp edges or points must be padded or covered. Bar-b-que pits are to have lids and doors always secured, except during judging.

All trailers must follow TXDOT requirements.

SILENT AUCTION:

The Ag Mech Committee will allow a Silent Auction to be held at the time of check-in until 6PM on Saturday of the Auction. Exhibitors that wish to participate will need to pick up a Silent Auction Form from the Ag Mech Committee at the time of check-in. Exhibitors are responsible for picking up their bid sheets at the conclusion of the Auction Sale and finish the transaction between the buyers. No "For Sale" signs will be allowed. The Ag Mech Committee will in no way be responsible for negotiating, bargaining, or collecting funds from the silent auction. The exhibitor and the highest bidder are to arrange for delivery of the project and any payment that needs to be made to the exhibitor.
